- 1. WAR MEMORIAL Upon receiving my most recent update, FoDDC Planning sought further guidance from their Heritage Officer. He has requested that we seek expert opinion on the proposed remedial action from War Memorials Trust. This is ongoing.
- 2. A40 VEHICLE ACTIVATED SIGNS There appears to be signs of significant progress over the last two weeks with Gloucestershire Constabulary now far more aware of what is needed by National Highways before the project can be moved forward. The police are looking to conduct speed surveys at two locations to gather data as the most recent statistics are from 2018. It may be of some benefit to set up a new Community Speedwatch Group if sufficient volunteers can be identified.
- 3. VILLAGE HALL HEATING The VH Chairman assures me that the heating should be working when needed during meetings and will be controlled by a Hive system which will be accessible to responsible people.
- **4. RED LION –** West Oxfordshire District Council (Publica shared services) advise that our request to redesignate The Red Lion as an Asset of Community Value remains under consideration.

HUNTLEY PARISH COUNCIL Agenda – 4th April 2023, Appendix 'B' NDP Update for the Huntley Parish Council, March 2023

There was been no activity this month as we have been waiting for the Regulation 16 consultation of the Design Guide to complete on 31 March.

We are expecting the final report from the Examiner in the next few days, following which, the NDP would normally have been submitted to the next full FoDDC Council meeting for approval to proceed to Referendum. Due to the FoDDC elections, this is unlikely to happen until May at the earliest.

The referendum is expected to take place during June or July 2023.
